#### **Clinical Innovations:**

## **Advising Program**

Created a high school advising program in which teachers volunteer to meet weekly with groups of 12 students, going far beyond the traditional guidance program by strengthening relationships and providing knowledge to students about how to negotiate within the high school, linking them to extra curricular activities, helping them with course selection, time budget, and follow up with homework assignments. The creation of the program focuses on strengthening relationships by building a "home base" and examining the infrastructure necessary to sustain staff commitment to the program. The program has received local and national recognition, with many school systems asking for assistance in development of their own programs, and student evaluations show that they find it supportive and helpful in meeting their academic goals.

## Safety Assessments

Developed a model for conducting safety assessments with adolescents who are aggressive in school, and many have experienced trauma or have an untreated psychiatric disorder. The assessment includes in-person interviews with teachers and administrators and home visits when appropriate, and results in active coordination for access to needed services and education to families about clinical options. I have presented this model at professional conferences, to school systems, and have trained many child psychiatrists and educators to perform these assessments.

## Report of Teaching and Education Innovations

# "Frameworks for Understanding Child and Adolescent Development" Curriculum for Adult Psychiatry Residents

Developed and taught a year-long course on normal and abnormal child development for adult psychiatry residents. The curriculum was selected as a model curriculum in 2013 by the American Association of Directors of Psychiatric Residency Training. The curriculum, refined over eight years, brings together dynamic lecturers and pertinent readings to provide the residents with both a conceptual overview of development and specific information and strategies they need to improve their practice with adults and families. The course exposes adult residents to critical information including how to assess family functioning, strengths, and vulnerabilities, normal and atypical child development, diagnostic formulation in children and adolescents, and differential diagnosis and assessment of suicidality in children and adolescents.

### School Consultation Rotation Program

Developed a ten-month school consultation rotation for child psychiatry fellows to teach them the necessary skills to provide assessments and consultations in schools. Skills for special education advocacy and school consultation are taught through a case-based model and review of assessments. The fellows are trained in how to communicate effectively with educators and provide professional development that enhances teachers' efficacy with students. This rotation has been referred to as a "cutting-edge paradigm shift," as child psychiatry programs generally provide little guidance in school consultation.

# <u>Harvard Freshman Seminar: "Finding Connections: Perspectives on Psychological Development</u> and Mental Illness"

The innovative Freshman Seminar program for Harvard undergraduates exposes first year students to a unique learning experience through close interaction with senior faculty. This small group freshman seminar introduces students to a number of topics relating to psychological and mental illness early in their college careers. The seminar combines medical readings that provide practical knowledge, narrative readings to understand how patients experience the meaning of illness and how development-related mental illness is portrayed in the press, and discussions with visiting speakers who are living with mental illness. Understanding how conditions such as autism, depression, and loss are described in both clinical research and literature helps students appreciate the biological vulnerabilities and relational patterns that may disrupt human connections. Freshmen facilitate and create final projects as varied as research projects, dance performances, and creative essays.

### The Behavior Code

The Behavior Code bridges the worlds of education and mental health, addressing a gap in teacher training and providing critical tools to enhance teacher effectiveness in meeting the needs of challenging students. The book *The Behavior Code: A Practical Guide to Understanding and Teaching the Most Challenging Students* distills the combined clinical and practical experience of Dr. Rappaport and behavioral specialist Jessica Minahan to enhance educators' understanding of the underlying psychiatric difficulties related to students' challenging behavior and to generate practical tips and concrete strategies to help turn a classroom around. Laying out a new framework for working with challenging students, the book uses case examples of students with oppositional, depressed, anxious or provocative behavior. Dr. Rappaport and Ms. Minahan have presented to thousands of educators around the country and abroad since the publication of the book to further disseminate this framework for working with students. Ms. Minahan published a follow-up book, *The Behavior Code Companion: Strategies, Tools, and Interventions for Supporting Students with Anxiety-Related or Oppositional Behaviors*, which provides additional guidance for teachers to understand and practice the components of this innovative framework.

## Narrative Report

As a child psychiatrist and former elementary school teacher in Harlem, I have had the good fortune to develop programs to work actively in schools and school-based health centers. For the past 23 years, I have worked directly with the Cambridge public schools, providing consultation that helps improve the lives of children who often have broken families, mental anguish, and limited access to resources. Previous generations of child psychiatrists evaluated school referrals in their private offices and then provided written reports, without ever observing the school environment or considering how the school culture could be contributing to the students' challenges. I bridged that gap as one of the first of a growing number of peers who provide critical support to students on site in the school to ensure progress. This change in direction represents a paradigm shift, and I have encouraged schools to intensify targeted mental health services to support struggling students with substantial emotional challenges.

My work as a consultant to Cambridge public school administrators and as a treating child psychiatrist has led to a national discussion about the obstacles schools face in terms of resources, school culture, and adequate supervision. As the consulting child psychiatrist at Cambridge Rindge and Latin School, I began work in a community in which many adolescents skipped class, failed courses, and had a high rate of suspensions. Recognizing this repetitive cycle, I thought schools needed a way to fortify students' ties with educators and increase the opportunity for students to become more self-reflective and play a more productive role in their education so I created an advising program. I supervised teachers, coauthored a curriculum, and integrated student and faculty feedback to enhance the program. While this curriculum was successful locally, I wanted people to develop this nationally and I was grateful that schools have frequently asked me to share my insights so that they could adopt positive solutions in their communities.

Immediately after the Columbine massacre when the threat of school violence became a major public concern, I began to develop a safety assessment protocol that expands the child psychiatry role to address school violence by intervening early with students who display aggressive behavior and/or may pose a threat to other students and teachers. My approach emphasizes an understanding of the context of the identified student's behavior by conducting a psychiatric

interview with the referred student, a separate interview with the family, and interviews with school personnel and involved mental health clinicians. By providing a sophisticated formulation that is case-based, this process generates multiple points of intervention.

I have trained new generations of child psychiatrists in this approach and presented nationally and written extensively to provide a rationale and framework for schools to be more responsive to the risks and vulnerabilities of these students. In a pilot study of the model, I found that nearly all of these aggressive students had serious underlying psychiatric illness such as post traumatic stress disorder, attention deficit disorder or bipolar disorder, and most were not receiving help and needed assistance with coordinating mental health services. I was thrilled to have this work and advocacy recognized in 2011 with the American Academy of Child and Adolescent Psychiatry's Sidney Berman Award for the School-Based Study and Treatment of Learning Disorders and Mental Illness.

My experiences developing this program helped me identify a clear lack in the research focusing on the perspectives of students and their families who have been identified by schools as potential safety threats. To address this gap, I recently conducted a first-of-its-kind qualitative study that explored students' and families' experiences of school safety assessments, as well as the events leading up to the assessment. The study was recently published in the International Journal of Violence in Schools. The study also acted a catalyst for building on the work I have done to teach school personnel about safety assessment to design a new type of course for school district teams, rather than individuals, that focuses on how to strengthen district safety assessment protocols through a broader look at discipline and internet policies, guardian engagement, school climate, and relationships with law enforcement and other community resources. The first course with Boston-area schools in 2018-19 was a success.

Through many years of consulting to educators and clinicians I realized how it takes a special skill to translate psychiatric concepts in useful ways for educators. I collaborated with Jessica Minahan, a behavioral analyst and special educator, to write "The Behavior Code: A Practical Guide To Understanding and Teaching the Most Challenging Students." Educators often struggle with how to connect and respond to students with the most challenging behavior because traditional classroom management strategies fail. This book is a fundamental resource to help teachers and other support staff understand underlying psychiatric symptoms of students with anxiety-related, oppositional, withdrawn, or sexualized behaviors. Using illustrative case examples, we combined behavioral and clinical approaches in a four-step process to generate more informed selection of practical accommodations and intervention strategies to reinforce positive behaviors and build students' skills. The book has become a valuable resource for school psychologists and educators nationwide, and it is a best seller for Harvard Education Press.

As a dedicated teacher myself, I have mobilized a new generation of child psychiatrists to collaborate with educators and to advocate for their patients to optimize their functioning in school. I developed a ten-month school consultation rotation for the child fellows to teach them the necessary skills to provide assessments and consultations in schools. For ten years, I developed and taught a yearlong course on normal and abnormal child development, which was selected as a model curriculum in 2013 by the American Association of Directors of Psychiatric Residency Training. For the last ten years I have taught the popular Harvard freshman seminar, "Finding Connections: Perspectives on Psychological Development and Mental Illness." I

mentor my students and expose them to research and clinical applications. I am also the course director for an annual HMS program "Treating Students K to 12: Clinicians and Educators," which provides training opportunities to educators from across the country.

I undertook the challenge of writing a memoir, *In Her Wake: A Child Psychiatrist Explores the Mystery of Her Mother's Suicide* that synthesizes my personal experience and clinical research. I illuminated the complex causes of suicide and exploring the lingering effects of family trauma while also conveying the process of healing. I offered this book to teach about prevention of suicide and to reach those who may be contemplating suicide to recognize the devastating loss on their families. Since its publication, I have made numerous presentations to professionals and to the public with outreach via print, radio, blogs, webinars, and television appearances to educate a broad audience about mental illness, how to provide support to a person who is suicidal, and how to understand children who have experienced loss by suicide. I contributed to writing guidelines for parents for the American Foundation of Suicide Prevention about how to approach children after a suicide.

In 2015, I wrote a one-woman play, *Regeneration*, about navigating illness while being confronted with mortality. In performing this play for medical providers, my goal is to help them see how their own vulnerabilities can nurture their capacity for empathy and motivate them to provide the small acts of kindness that mean so much to their patients and give them the strength to cope with a serious health challenge. In performances for lay audiences, I hope to inspire them to use creativity as a way to overcome challenges. By creating a narrative of a challenge, we make meaning of the event and maintain the vital connections that sustain us.

My day-to-day goal is to advocate for comprehensive support with our most vulnerable children, who often require child psychiatrists to mobilize in a way that is different from the traditional model. As an educator, I teach this message of support to the students in my freshmen seminar at Harvard as well as to my residents. My passion as a teacher and clinician is to better the lives of the young people I treat and to pass my knowledge on to the future practitioners who will carry on the work I pioneered.
